At https://heidelbergkerlinfarm.wordpress.com/history/bolton-family/, says in part, "The Boltons are descendants of an ancient English family that owned landed estates located in both Lancashire and Yorkshire during the time of the conquest (The Norman conquest of England by William the Conqueror in 1066). Originally Bodelton, the family has traced their ancestry back to about 1135, and to the Lord of Bolton, representative of the Saxon earls of Murica. Everard Bolton likely descended from the titled Bolton family. His parents, William and Mary and family, were Friends who suffered persecution with others on account of their religion (Quaker). Because of this, Bolton decided to come to America and take part in William Penn's, "Holy Experiment." Everard sailed to Pennsylvania on the ship Bristol Factor, with his wife and two children in 1682. As a Quaker, he brought a certificate of removal dated August 19, 1682, with him." It's unknown if he is related to our subjects, William James Bolton/Boulton or his brother, John Thomas Boulton.

Bodeltune (Bolton), a location, is mentioned 28 times in the Domesday Book, a manuscript record of the "Great Survey" of much of England and parts of Wales completed in 1086 by order of King William the Conqueror. Bolton was a settlement in the hundred of Pocklington and the county of Yorkshire. It had a recorded population of 2.7 households in 1086, putting it in the smallest 20% of settlements recorded in Domesday and is listed under 2 owners. Boulton was a settlement in the hundred of Litchurch and the county of Derbyshire. It had a recorded population of 5 households in 1086, putting it in the smallest 20% of settlements recorded in Domesday.

At https://www.familysearch.org/wiki/en/Bolton (city), Lancashire Genealogy, says "Bolton is a common Northern English name derived from the Old English bothl-tun, meaning a settlement with a dwelling, as opposed to a settlement without a fixed dwelling. It was recorded as Bothelton in 1212, Botelton in 1257, Boulton in 1288, and Bolton after 1307. Later forms of Botheltun were Bodeltown, Botheltun-le-Moors, Bowelton, Boltune, Bolton-super-Moras, Bolton-in-ye-Moors, Bolton-le-Moors. Also, at this website it says, "During the English Civil War (1642-1651), the people of Bolton were Puritans and supported the Parliamentarian cause. A parliamentary garrison in the town was attacked twice without success, but on 28 May 1644 Prince Rupert's Royalist army with troops under the command of the Earl of Derby attacked again. The attack became known as the Bolton Massacre in which 1,500 died, 700 were taken prisoner and the town plundered." Religion was a major cause of the English Civil War. It was part of a Europe wide conflict between Roman Catholicism and Protestantism. At the start of his reign (1625) King Charles I, had married the Roman Catholic Henrietta Maria of France. In London, King Charles I, is beheaded for treason on January 30, 1649. Charles ascended to the English throne in 1625 following the death of his father, King James I. In the first year of his reign, Charles offended his Protestant subjects by marrying Henrietta Maria, a Catholic French princess. At https://www.surnamedb.com/Surname/Boulton, says "This interesting name is of Anglo-Saxon origin, and is a dialectal variant of the locational name Bolton, so called for example: Bolton in Cumbria (near Wigton); in

Lancashire (near Urswick); also Bolton in Northumberland, Westmoreland and in the West Riding of Yorkshire. The name, in all cases derives from the Olde English pre 7th Century "bodltun", composed of the element "bodl" or "botl", a dwelling house or hall, plus "tun", an enclose or settlement; hence, "dwelling house or hall in the enclosure." Locational surnames were usually acquired by a local landowner, or by the lord of the manor, and especially by those former inhabitants of a place who had moved to another area, and were thereafter best identified by the name of their birthplace. The surname is first recorded towards the end of the 12th Century (see below). There are two notable namebearers listed in the "Dictionary of National Biography:" one Richard Boulton (1697 - 1724), a physician, who published medical works; and one Matthew Boulton (1728 - 1809), an engineer who entered partnership with Watt, who he greatly assisted in the completion of the steam engine. The first recorded spelling of the family name is shown to be that of Robert de Boulton, which was dated 1191, in "Early Yorkshire Charters," during the reign of King Richard I, known as "Richard the Lionheart," 1189 - 1199. Surnames became necessary when governments introduced personal taxation. In England this was known as a Poll Tax. Throughout the centuries, surnames in every country have continued to "develop" often leading to astonishing variants of the original spelling.

An excellent site about the Bolton/Boulton family is titled, Bolton Family Crest, Coat of Arms and Name History, at https://coadb.com/surnames/bolton-arms.html. Although partially a commercial site, offering merchandize for sale, this site is very comprehensive in its sharing of the Bolton Surname Name Meaning, Origin, History, & Etymology. One excerpt from this section says, "William Boulton was born c. 1175 AD in Boulton, Yorkshire, England. His son, William Bolton or de Boulton, was born in Harewood, Yorkshire, England in 1196 AD. He died in 1287 at the same location. He married Emma Ruffus and had a daughter with her named Elizabeth. Elizabeth was born in the same town in 1222 AD. She married William Gasciogne V in 1248 AD, and had a son with him named William VI. Robert de Boultron was recorded in the Early Yorkshire Charters in 1191 AD. Thomas de Bolton was recorded in Warwickshire, England in 1262 AD. The Hundred Rolls of 1273 AD, a census of Wales and England, known in Latin as Rotuli Hundredorum lists two bearers of this surname: Michael de Boulton (Yorkshire) and Thomas de Boulton (Lincolnshire). Adam de Boultone was reeve of Dunfres, Scotland in 1287 AD. The Placita de Quo Warranto documents Ricard de Boulton in Northumberland c. 1292. William fitz Geffray de Boiultone del counte de Edeneburk was documented in 1296 AD. John of Boulton was a mason at the Castle of Linlithgow in Scotland in 1302 AD. Robert Bolton was documented in Lancashire in 1371 AD. The Poll Tax Rolls of Yorkshire in 1379 AD also lists one bearer: Agnes de Bolton." It's unknown if any of these persons with a Bolton-type surname are ancestrally related to our subjects, William James Bolton/Boulton or his brother John Thomas Boulton.

A unique resource was identified on the overall Bolton/Boulton family is the publication called, *The family of* Bolton in England and America, 1100-1894, a study in genealogy. Embodying the Genealogical and biographical account of the family of Bolton, published in 1862 by Robert Bolton, rewritten and extended to date, by Henry Carrington Bolton, published in 1895, at https://www.seekingmyroots.com/members/files/G000851.pdf. In this publication was found a section titled "Boltons in the City of London," on pages 108-29, which may be the Bolton/Boulton ancestral line, since William J. Boulton was impressed into the Royal Navy while living in London in about 1807. The very most of these Bolton/Boulton and other strange spellings of this family surname appear to be in the 16th and 17th centuries, about 150 years before our Bolton/Boulton subjects were born. This section speaks to a Sir William Bolton who was mayor after the fire of London, which started Sunday, 2 September and lasted through Thursday, 6 September 1666, see https://en.wikipedia.org/wiki/Great Fire of London. Lord Mayor, Sir Thomas Bloodworth was mayor at the time of the fire and that Sir William Bolton, at https://en.wikipedia.org/wiki/William Bolton (Lord Mayor), replaced him, although it appears that Sir William was not very good at administrating finances of rebuilding London. It is said at https://www.historyextra.com/period/stuart/great-fire-london-story-how-why-started-destroyed-capital-puddinglane-samuel-pepys/, Sir William Bolton, for whom everyone had high hopes after Bloodworth, was in charge of administrating the £12,000 raised. It all ended in scandal, however, when he couldn't account for £1,800 and had to resign. Pepys, no fan of his predecessor, called Bolton's actions "the greatest piece of roguery that they

say was ever found in a Lord Mayor." It goes on to say at https://en.wikipedia.org/wiki/William_Bolton_(Lord_Mayor), "Bolton (who died in 1680) was a city of London merchant and a member of the Worshipful Company of Merchant Taylors. In 1659 he was elected an alderman of the City of London for Castle Baynard ward and became Master of the Merchant Taylors Company. Also in 1659, he was colonel of the Blue Regiment. He was one of the Sheriffs of London from 1660 to 1661 and was knighted on 11 October 1663. In 1666, he was elected Lord Mayor of London. However, he was unable to account for £1,800 of the collections made for those who suffered in the Great Fire of London and was accused of cheating the poor of the City. As a result, he was barred from attending the Court of Aldermen while an inquiry took place and eventually had to resign his seat. He became very poor and on 19 March 1677 the Court of Common Council voted him a pension of £3 per week." This same Bolton resource traces the Bolton/Boulton ancestry back to Lord Oughtred DeBolton (1080–1155), Bowland, Yorkshire, England. Whether this Sir William Bolton is an ancestor of our Bolton/Boulton family is unknown.

One major reason why our Bolton/Boulton family may not be uniquely found in this resource is because of the name Bolton/Boulton itself. The meaning of Bolton/Boulton appears to be derived from a place or a settlement as stated above. Knowing this, many surnames were derived from locations. So, back in the day, if you lived in a Bolton/Boulton settlement, your name could have been John or Ann of (de) Bolton/Boulton, shortened meaning John or Ann Bolton/Boulton. But just because of your name, doesn't mean you are in fact an ancestor or descendant of our Bolton/Boulton ancestral family. Only through DNA testing, from a confirmed William James or John Thomas Bolton/Boulton ancestor or descendant, could it be possible to be part of our Bolton/Boulton family. So, it's very possible, the main reason we may not be uniquely found in *The family of Bolton in England and America*, 1100-1894, publication is because we are not at all related to these Bolton/Boulton families.

Genealogical and biographical account of the family of Bolton in England and America, deduced from an early period and continued down to the present time, by Robert Bolton, published in 1862, at https://babel.hathitrust.org/cgi/pt?id=wu.89058582750&view=1up&seq=7&skin=2021, is also an excellent resource on the Bolton/Boulton family, which is similar to *The family of Bolton in England and America*, 1100-1894.

The earliest Bolton/Boulton to America, that has been found is Johanna Bolton at https://www.familysearch.org/ark:/61903/1:1:KCH2-FP5. In this resource, it states that Johanna came to Boston, Suffolk Co., Massachusetts, British Colonial America in 1592, aboard the ship Bosphorus from Liverpool, England. She was 23 years old, born in Ireland in 1569. Her occupation is listed as a spinster, and she is also listed as an invalid. In this case, it's very likely that Johanna was both an unmarried woman and a woman who spun thread and yarn, since spinster was listed under an occupation category. In the case of being an invalid, she was likely a person made weak or disabled by illness or injury.

It appears that the first male Bolton/Boulton to America was Richard Boulton, who landed in Virginia in 1610, according to *Passenger and immigration lists index: a guide to published arrival records of about 500,000 passengers who came to the United States and Canada in the seventeenth, eighteenth, and nineteenth centuries, by William P. Filby and Mary K. Meyer, 1982-1985 Cumulated Supplements in Four Volumes Detroit, MI: Gale Research Co., 1985, Print (ISBN 0-8103-1795-8). At https://www.wikitree.com/wiki/Boulton-408, suggests Richard was born about 1582. Richard Boulton age 28 immigrated to Virginia in 1610 aboard the ship Mary & James. Some additional information on this Richard Boulton and descendants can be found at https://sites.rootsweb.com/~tnsmith/oldpics/boulton history.htm.*

The earliest ancestral link to William J. Boulton, we believe, would appear to be William's great grandfather, Abraham Bolton, b. about 1718, Tottenham, Bedfordshire, England, d. 19 October 1764, Ulverston, Cumbria, England.

William James Boulton Detail

It was first thought that William James Boulton was born in London, England on Piccadilly St., 24 June 1798, confirmed through William's U.S. Naturalization Record, dated 18 September 1833, Orleans Co., NY, at https://www.familysearch.org/ark:/61903/1:1:OPRR-DZMV.

But David Boulton who lives in Australia, a cousin of Ed Haynor, provided a baptismal record for William's birth, listed as Willm, baptized August 1798, with his birth recorded as June 1796, a full two years before William's U.S. Naturalization Record. The baptismal record shows William's parents as Abraham and Charlotte Bolton. This record is from London, England, Church of England Baptisms, Marriages and Burials, Westminster, St. Marylebone, 1538-1812, found at ancestry.com.

William Boulton's parents were Abraham William Bolton, b. 19 June 1773, d. 7 April 1847 and Charlotte Stocker, b. 1775, d. 12 April 1855. Abraham and Charlotte were married 29 May 1796, St. Mary's, Willesden, Brent, Middlesex, England, as recorded at, London, England, Marriages and Banns, 1754-1921. It's believed that both of William's parents died in England.

So, is this baptismal record, correct? If so, why? The probable answer is that Abraham and Charlotte had a baby, approximately one month after they were married at St. Mary's, since Charlotte was already pregnant. The authors have learned that marriage "in England from the fourteenth

This can be demonstrated by the fact that 25 per cent of seventeenth-century Englishwomen had already been pregnant at the time of the wedding. This was not judged as harshly as we might expect. Being able to have children was a matter of an absolute importance in a woman, so having sex before marriage was the only way to 'confirm' this ability." Also, at this site it says, "the main purpose of marriage was having children. It was not only ensuring an heir that was significant; the husband could not act as the head of a family until his marriage had produced an offspring, so it was also a matter of social prestige. For a woman, the whole thing was even more serious. Infertility was perceived not only as a social defect, but as a downright punishment by God." It appears Abraham and Charlotte were part of this 25% and used William's baptismal year as William's birth date to avoid any adverse effect to William, his siblings, and his own family, later in life. If William was born a full two years before the recorded date on his Naturalization Record, as this baptism has recorded, William probably never knew of his actual birth date.

The cousin David Boulton from above, is the direct descendant of Thomas Boulton, William's brother, born 29 December 1811, Binfield, Berkshire, England, died 14 January 1896, North Sydney, New South Wales, Australia. Because of this Thomas being born 15 years after William, they likely never knew each other, since in about 1807, William was impressed into the British Navy, before Thomas was born (see right hand section), unless of course, they somehow corresponded through letters between the U.S. and England and later between the U.S. and Australia.

service's offices were called 'Rendezvous' with a Regulating Officer in charge, and he hired local hard men as 'gangers'. These thugs would thus roam the countryside attempting to 'encourage' men aged between 18 and 55 to join the navy. Noone was safe from the gang, and often the only escape route when captured was to bribe the gang or to join it. A preferred target for the pressgang was the merchant navy, so it was not infrequent to find special hiding places on merchant vessels. Also, the return of prisoners of war from France was also seen as the perfect moment to impress crewmen, such that very often the returning POWs were turned round and pressganged even before they set foot once more on home soil. The captains of merchant vessels frequently took pity on those they were repatriating and tried to let them land in places far from the ports and the pressgangs."

William's U.S. Naturalization Record, says that he arrived in the town of Madrid, St. Lawrence County, NY, on either the 15th or 16th of August 1811

Madrid, NY, is about nine miles from the St. Lawrence River, dividing NY State and Canada. During the War of 1812, Madrid, due to its proximity to Canada, developed a town militia, the "South Madrid Militia," see History of Madrid, NY, at https://history.rays-place.com/ny/madrid-ny.htm and History of St. Lawrence Co., New York, at https://ia800207.us.archive.org/14/items/cu31924028833015/cu31924028833015.pdf.

The aforementioned Naturalization Record also says that since our William's arrival in the U.S., in 1811, he's lived in the U.S., ever since, with 17 of those years, living in Orleans Co., NY, specifically in the towns of Gaines and Carlton and holds a valuable farm by contract in Carlton.

In the publication "Landmarks of Orleans County, New York," Syracuse, N.Y.: D. Mason & Co., published in 1894, there are two references to William J. Boulton. In Chapter XXIV, THE TOWN OF CARLTON, on page 627, it says, "The south part, 60 acres, of lots 1, 3 and 5, sec. 2, was taken up by Barnabas Lowell July 16, 1824. It was articled to William J. Boulton, December 6, 1833, and deeded to Jacob Lawrence August 6, 1836." On page 628, it says, "The middle part of lots 1, 3, and 5, sec. 4, 100 acres, was deeded to the First Congregational church in the town of Gaines April 25, 1822. The south part of lots 1, 3, and 5, sec. 40 acres, was taken up by William J. Boulton, July 14, 1821. It was articled in two parcels to Heman Logan and Samuel Hale July 26, 1833; and to John H. Nichols December 3, 1834." So, it would appear that William, was in Gaines in July 1821 and property he owned in July and December 1833, he deeded away in December 1834 and August 1836 respectively. So, it's possible that his daughter Nancy who was born in 1835, was born in New York State, rather than Michigan, unless land deed sales were conducted, at least in part, through the mail back in those days.

Although the Boulton Family has gone primarily by the Bolton or Boulton surname in England, William's name was recorded as Boulton on the Naturalization Record. As stated in an undated letter by Mary Elizabeth

Emigration to Australia

The Thomas Boulton family departed Liverpool, England, 21 October 1856, on the Matoaka (some spell it Mataoka). The voyage took 95 days and they landed at Sydney Cove on the 22 January 1857. They were bounty immigrants, the total cost of the bounty was 13 pounds 4 shillings and 9 pence per person. Thomas occupation was given as Stonemason and Labouror, daughters Rosehannah and MaryAnn were House Servants; sons Abraham & William were Labourers. In 1857, the Boultons were living at Primrose Villa at the time of Rosehannah's marriage. In 1860 Family living at Avondale Thomas and Eliza owned land which was part of the Marshall Estate and is still listed as Lot 1, situated in the expressway turn off to Dapto "In New South Wales, assisted immigrant records may also be supplemented by a series of records known as the Immigration Deposit Journals. These are a record of the monies paid towards the cost of an immigrant's fare and can, once again, provide some very interesting clues. These records show, for example, that Thomas Boulton (note the spelling) paid monies towards the cost of the voyage of the Jones family. The Journals show a distinct discrepancy in the ages of James and Mary Jones which are stated as 38 and 48 respectively. The family is also described, on this occasion, as being of Vinfield, Berkshire while a Mr. J. Lawrence of the same place is listed as 'some person of note to whom reference can be made respecting the emigrants'. (Conner) Haynor, William added a letter "u" to his surname once in the U.S. and that he was born on Piccadilly St. in London.

Mary Elizabeth (Conner) Haynor, also stated in her letter that:

¹ William's father was a landlord in Lincolnshire, England, When quite young, William was impressed aboard a Man-of-War England gun boat (known as a 74) at a wharf in London to be a sailor. He was on this ship for four years.

When making his way to New York he hired out as a farm hand to ²Barney Kelly (Kelley). Barney was thought to have been a bodyguard of George Washington, as told to his grandson, Albert Clements Haynor. Barney Kelly (Kelley) was tall of Scottish heritage, about 6' 2" and that Nancy Hunter, Barney's wife's maiden name, was English. William Boulton married their daughter Nancy L. Kelly. ³ About 1825 they moved to Lenawee County, Michigan near a small village which he named Palmyra. William J. Boulton was commissioned Captain by Governor John Barry (Michigan) the 25th of April 1842. He trained soldiers and his training on the gun boat was military tactics and drilling. He was known as Capt. Boulton for years.

⁴ William J. Boulton died in 1881 (actually 1885), at the home of his daughter Nancy (Boulton) Haynor in Easton, Ionia Co., Mich.

The post office opened March 27, 1833." We have no reason to believe that this finding is not true, since no other findings can dispute it.


Although another Internet site named "From Palmyra, NY to Palmyra, MI, Our Migrating Ancestors," at

https://wayne.nygenweb.net/palmyra/palmyrami.html, seems to confirm that William J. Boulton was a migrating ancestor, but apparently not an original one, since his name is not listed from those who came as early as 1823, up through the 1830 Lenawee County, MI census, since he is not listed in this census at http://kent.migenweb.org/census/1830/lenawee.html. Unfortunately, his name in the Internet publication from above is misspelled as "Borilton William J."

Our William J. Boulton also can't be found in the 1840 Census either, but somehow the "From Palmyra, NY to Palmyra, MI, Our Migrating Ancestors," publication found him somehow/somewhere. Perhaps it was the William Boulton in Hillsdale County, dated 8/2/1837. Hillsdale County is adjacent to Lenawee County. 


The Matoaka

There exists a 20-page document called the "Diary of James Ball, Voyage of Emigration, England to Australia aboard the Matoaka, 1856-57." The authors intended to give a summary of some important perceptions and events, as recalled by James Ball, age 43, an emigrant passenger aboard the Matoaka, from Wednesday, October 15, 1856, which ship left Liverpool, England on Monday, October 20, that arrived in Sydney Harbor, Australia on January 22, 1857. But the authors have found their attempt to give a summary, find it impossible because of the nature of the diary. There's just too much important information to share, which doesn't give the diary any justice. According to http://oceans1.customer.netspace.net.au/austrun-wrecks.html, the "Matoaka. Emigrant ship, wood, 1092 tons. Built

in New York, and Nancy, Wallace and Lucious born in Michigan. So, as child Nancy was born in Michigan, with her age listed as 14, she would have had to be born no later than 1836. So, based on this census, verifies William J. Boulton's presence in Palmyra, Lenawee, Michigan, no later than 1836, confirming the work of "From Palmyra, NY to Palmyra, MI, Our Migrating Ancestors," Interestingly, the 1850 U.S. Census has William's name listed as William D. Boulton. When you look at the actual handwritten census page, William's middle initial is very hard to read, actually, unreadable.

According to the Ancestors of Erin Boulton at, https://www.genealogy.com/ftm/b/o/u/Erin -Boulton/GENE2-0007.html, William J. Boulton, "Came from England via Adelaide, Australia in 1812 on a British Man of War (known as a 74); deserted with 5 others upon landing at Quebec. Enlisted with USA in war of 1812. After the war, he worked at St. Catherine, Ontario, then moved to New York and served as a captain in the NY Militia. Moved to Lenawee Co., Michigan in 1835."

The author notes that St. Catherine, Ontario, is likely St. Catharines, Ontario, which is located on the southwest corner of Lake Ontario, about as far as a ship could travel on the St. Lawrence River at that time. The distance from St. Catharines, Ontario to Niagra Falls, NY, is about 14 miles. But the distance from St. Catharines, Ontario to Madrid, NY, as William stated in his 1833 Naturalization Record is about 312 miles and that Madrid is right across the river from Quebec, as Erin Boulton states above. The author believes that it would be hard to understand why William would go back into Canada, for any reason, since he would be putting his life in jeopardy, since he would be reported in Canada as a deserter.

Although the HMS Victory is a 104-gun first-rate ship of the line of the Royal Navy, ordered in 1758 and launched in 1765. She would, more or less, look like a larger size 74-gun Man-O-War. The HMS

Victory is best known for her role as British Lord Nelson's flagship at the Battle of Trafalgar on 21 October 1805.

After 1824, the HMS Victory was relegated to the role of harbor ship.

In 1922, she was moved to a dry dock at Portsmouth, England, and preserved as a museum ship. She has

been the flagship of the First Sea Lord since October 2012 and is the world's oldest naval ship still in commission, with 244 years' service as of 2022. More on the HMS Victory can be found at https://en.wikipedia.org/wiki/HMS Victory.

In regards to William enlisting in the War of 1812, a William J. Bolton was listed at

1853. Lbd 198.8 x 37.9 x 22.3 ft. Purchased by Shaw, Savill and Albion Company in 1867. Captain Stephens. Left Lyttelton, New Zealand, for London on 13 May 1869, with forty-five passengers, including thirteen women and eighteen children, a crew of thirty-two, and a cargo of wool and gold. She was not seen again, and it was thought she had probably struck an iceberg or been destroyed by fire. In 1868 she carried a consignment of thrushes, blackbirds, sparrows, finches and robins for New Zealand; their descendants are now legion."

It's believed Thomas and Eliza had the following children:

Five Generations

(Pictured above in the center), Mrs. R. (Rose Hannah) Murley, of Warfield, Dapto (in the Illawarra district), who is 85 years of age, is a native of Berkshire, England. She came to Sidney with her parents in 1857 and went to live at Dapto. On her marriage she removed to Ballarat. She arrived there the day the Nil Desperandum gold nugget was found, and later saw the Welcome Nugget, which was exhibited at Ballarat for some time. Returning to New South Wales, she again settled in the Illawarra district, where she still resides. She is the mother of 12 children – 10 sons and two daughters – 27 grandchildren, 21 great-grandchildren, and one great-great-grandchild. The five generations represented in the photograph are: Mrs. Murley; Mr. William J. Murley (son) of Belmore street, Burwood; the latter's eldest daughter, Mrs. H. King, of Angel street, Burwood' Mrs. King's eldest daughter, Mrs. P. Scott, of Strathfield; and Mrs. Scott's baby, who is Mrs. Murley's great-great grandchild.

Note: Rose Hannah may have been blind. It's believed that she used to make marble bags for the missionaries to give to children. She was a staunch member of the Presbyterian church at Dapto and was supposed to have been a founding member. Rose Hannah was described as a tiny lady who was most always dressed in black. She wore a little black beaded bonnet with strings tied under her chin. She outlived many of her children.

Since our William previously was in the British Royal Navy, this author is assuming that William's involvement in the War of 1812, likely would have been with naval engagements, but so far, there is no proof of that. A good source of history on the U.S. Navy and the War of 1812 can be found at https://military-historian.squarespace.com/blog/2015/1/4/the-war-of-1812-the-us-navy.

At Familysearch.com lists 22 men with the surname Boulton who were in military service in the War of 1812, none with a first name of William. Although there is one "William Bolton" listed as a private in Swift's 2nd regiment New York militia at

https://www.familysearch.org/ark:/61903/1:1:Q29V-R3BW. Philetus Swift (1763-1828) was in command of the 2nd regiment, listed as a lieutenant colonel. Later in life, Swift became a state senator from the western district NY State. It is believed that Swift had at least some involvement with actions along the American-Canadian border, which is categorized in three sectors, southwestern Ontario adjacent to the Detroit River, the Niagara Frontier (including the adjacent coast lines of Lake Erie and Lake Ontario in Upper Canada, New York and Pennsylvania), and the St. Lawrence River (including locations in Lower Canada and New York).

farmers of Palmyra township (Lenawee County, MI), was born in Orleans county, New York, March 14, 1832. He is the son of William J. and Nancy (Kelly) Boulton. the former of whom was born in London, England, June 24. 1798, and the latter at St. Albans, VT of scotch parentage in 1800 (or 1803). (William J. Boulton) came from Adelaide, Australia to America in 1812 on board a British man-of-war, known as a seventy-four, and he and five others deserted as soon as the vessel landed at Quebec. He then made his way to the lower end of Lake Ontario and at once enlisted in the States service in the War of 1812. For a time after the war he worked at Saint Catherine, Ontario, then went to New York, where he engaged in agricultural pursuits, and while there served as a captain in the New York militia. In 1835 he moved west to Lenawee county, Michigan, and purchased the property where the son (George) now resides, clearing and improving the same. He remained on the farm until his death, which occurred in 1886 (21 April 1885 at the home of his daughter Nancy Boulton (Haynor) Easton Township, Ionia County, MI), just thirty years after his wife's demise."

In the early development of Michigan, it was common for early settlers moving west from eastern American states as well as eastern Canada, starting in the early 1800s to settle in Michigan using federal and state land grants. Michigan was a public-domain state where unclaimed land was surveyed, then granted or sold by the government through federal and state land offices. The first sale of a piece of land from the government was called a land patent and the first owner of the land was called a patentee. Later, when the land was sold or mortgaged by private owners, the document was called a deed. The first federal and state transactions were recorded and the paperwork kept at the federal and state level, while all future transactions were recorded at the office of the county register of deeds. No land grants at

https://glorecords.blm.gov/search/default.aspx, can be found for William J. Boulton in Lenawee Co., MI. One can be found for a William Boulton in Hillsdale County, dated 8/2/1837. An additional land grant can be found for a William Boulton in Allegan County dated, 5/1/1839. Whether any of these grants are for our William J. Boulton is unknown. Two land grants were found in Lenawee County for a Thomas Boulton, dated 9/10/1834 and for George Boulton, dated 10/6/1835. Who Thomas and George Boulton are, is unknown. It's possible that William J. Boulton, bought property from one of these early Boulton men, as he likely made the move from NY State to Michigan near 1835 for his daughter Nancy L. (Boulton) Haynor, to be born in Palmyra, Lenawee County in November 1835



- 1 Lincolnshire is about 140 miles from London. Binfield, Berkshire, England, where William J. Boulton's siblings were born is on the outskirts of London, about 40 miles away. This author wonders if the author's grandmother, Mary Elizabeth Haynor meant Berkshire rather than Lincolnshire?
- It has not been proven that Barney Kelly (Kelley) was ever a bodyguard (known as a lifeguard back then) to George Washington, although most lifeguard records were lost in a fire in the early 1800s. About 75% of the known lifeguards have been recovered through other sources, with the best comprehensive list this author has found is at http://genealogytrails.com/main/military/eliteguards.html, which includes a brief history of the lifeguards. If Barney was 6'2" tall as Mary Elizabeth Haynor described him, Barney may have been a body double, rather than a bodyguard. If so, with General Washington being so secretive regarding spies, informers, etc., we may never know if our Barney was a body double. It's possible too, that it wasn't William James Boulton's father-in-law Barney who was a bodyguard or body double, but it was Barney's father-in-law William Hunter who was the bodyguard, since a William Hunter was found to be an actual bodyguard of General Washington in the source above, and we know that Barney was married to a Nancy Hunter, if in fact this Nancy is a daughter of this William.
- Although William and Nancy moved to Lenawee County, Michigan, it probably was not as early as 1825 (although Mary Elizabeth (Conner) Haynor, might have meant to write 1835), since son George was born in Orleans County, NY, in 1832, but daughter Nancy was born in Lenawee County in 1835. William and Nancy did move from NY State to Palmyra, MI. But this author can find no records of William and Nancy moving specifically from Palmyra, NY to Palmyra, MI or of William's naming the Michigan village Palmyra. It's possible that Thomas Boulton who arrived on 22 January 1857, on the Matoaka, might have obtained cheaper fair, listing William as a Boulton, rather than a Jones. It's possible too, that William was born before Esther and James were married, therefore, born a Boulton. But in the British Isles Census of 1851, at https://www.familysearch.org/ark:/61903/1:1:SG8P-ZKS, William is listed as William Jones, a son of James Jones, age 12, born in or near 1839. Immigration records have William Boulton arriving also on 9 June 1869, 7 November 1871 and 4 December 1872. He was a cook/steward on a number of ships. In the paper, "Charity and poverty in Binfield, Berkshire 1775-1875: A Study of 'Industry', 'Desert' and Social Deference," Social History Society Conference, Trinity College Dublin, January 2005. This is an updated and supersedes a similarly titled paper for 10th International Economic History Conference at the University of Louvain (1990), by Margaret Escott, University of Reading, History, Visiting Research Fellow. This author found our Bolton ancestry mentioned through both Abraham born 1747 and his son born 1773. Here are some excerpts from that paper that applies to our Bolton family, especially as it applies to poverty during that time period:

- Page 8 "Most charity donations were paid out in cash to non-paupers when tithes were collected on St. Thomas's Day, with eligible persons benefiting every two or three years. However, records show that sums were also set aside, or requested at short notice from likely benefactors, 'for such accidental calls as sickness or other calamity may point out' to try to ensure that a particular family or individual was not pauperized through a chance stroke of bad fortune. Thus, when Abraham Bolton's son (b. 1773, d. 1847) lost a guinea in 1783, his father (b. 1747, d. 1800) received 10 shillings and sixpence from Lord Suffolk and the same from the rector as extraordinary charity donations."
- Page 11 "Desert (abandoned, shunned or neglected) as could be readily accrued if an individual or family was known and approved of by parish authorities, but those not considered especially deserving received commensurate relief, provided the overseers confirmed their eligibility. The policy of making payments when tithes were collected, itself deterred at least one potential recipient (Thomas Aldrich, husband of Elizabeth Bolton, b. 1775); while evidence that parish patronage was sometimes resented comes from Abraham Bolton's (b. 1747, d. 1800) 'damning of the gifts' before the churchwardens; the decision of the wives of John Sargent and William Vickery to collect their guineas unbeknown to their husbands⁶⁵; and a concerted but abortive attempt to widen access to the office of rate collector in 1801."
- Pages 17-18 "A glimpse of how families who remained in observation coped with the transition from an informal 'juggle of resources' to a system dominated by conscious applications for reward and concomitant invitations to have their behaviour monitored is offered in the following case studies: one of the Boltons, admired by Wilson for their independence and 'industry'; and one of the Dowlings, 'Poor Labourers'. Abraham Bolton's (b. 1747, d. 1800) descendants remained independent of parish relief throughout. His widow died aged eighty-two in 1824, outliving Abraham by twenty-nine years. She paid her taxes, collected charity doles, apparently kept a grandchild in residence and passed on the partly owned/partly rented smallholding built up by her husband to her son Benjamin. Family fortunes were blighted by many early deaths including the loss of two daughters early in their married lives but their surviving offspring and those of her married sons remained in the parish. Family births and deaths were frequent. Benjamin and Abraham Bolton Jnr. (b. 1773, d. 1847) both sought charity assistance. In 1824, Abraham was the first recorded applicant to be refused admission to Bowes's Batson's and Wilson's charity. He was then forty-nine, married, and lived in a tied cottage (a dwelling owned by an employer that is rented to an employee: if the employee leaves their job, they may have to vacate the property; in this way the employee is tied to their employer). His children were between twelve and twenty-eight years old. He died in 1847 aged seventy-four. His brother Benjamin, who when widowed returned home to live with his mother, received twenty-seven shillings triennially from the charity and was never 'warned'. Benjamin's sons, James, John and Benjamin Jnr. were each admitted to the Charity in turn and also had their requests for places at the Charity School for their children granted. However, the trustees reprimanded James formally in 1841 and thereafter his name disappeared from the lists. Benjamin Jnr and John's w

The hotel, a Grade II listed Georgian mansion, is also home to the National Trust-owned folly the "Temple" on the end of a stone jetty on Windermere. Situated in the Lake District, Storrs Hall sits alongside the Windermere. It stands in seventeen acres of grounds and woodland.

The mansion was first built in the 1790s by Sir John Legard, a Yorkshire landowner. After 14 years of owning the building, Sir John Legard became increasingly crippled by gout, and eventually sold Storrs Hall in 1804.

The new owner of Storrs Hall was John Bolton, born in Ulverston in 1756, who was a rich man and one of the wealthiest men of his class. He extended the mansion and created a park. John Bolton was a Cumbrian who made a fortune as a Liverpool slave trader. He bought Storrs Hall with some of the proceeds and used the residence to entertain in style, holding regattas on the lake which were attended by Wordsworth and Sir Walter Scott amongst others.

Elizabeth Bolton died in 1848 and the hall passed to her nephew Reverend Thomas Staniforth. Thomas was the son of former Lord Mayor of London Samuel Staniforth and grandson of Thomas Staniforth, also former mayor and slave trader. Staniforth moved into the hall in 1859 after retiring from his parish and lived there until he passed in 1887. As he never had any children the estate was sold off in lots.

Between 1940 and 1944, Storrs Hall (which had previously been used both as a girls' school and as a youth hostel) played host to the staff and boys of St Hugh's School, Woodhall Spa, who were evacuated from their own buildings amidst the airfields of Lincolnshire during World War II.

Today, Storrs Hall is a 4-star hotel.
